#2. Late-breaking announcements are made via e-mail (Race Alerts) from the web site and/or Facebook. Sign up for Race alerts at [skicmsc-racing.com](http://skicmsc-racing.com).

#3. Register online at [skicmsc-racing.com](http://skicmsc-racing.com) if possible. Online registration ends Friday at midnight before the race or at the discretion of the registrar.

#4. On-hill registration ends one hour prior to start of the race. No Exceptions!!

#5. Racers **MUST** have a lycra bib to earn points. Point accumulation begins the day the payment is received.

#6. All racers are encouraged to join a CMSC member ski club race team as soon as possible. Away hill only racers may select Local. New racers may initially race as INDEPENDENT for a predetermined number of races, before being required to join a club.

#7. Racers will not be issued a bib or allowed to race until a completed CMSC Registration Form and Liability Waiver has been submitted to the Registration Chairperson.

#8. Discounted packages have expiration dates. Check website for details.

## Alpine Racing - Waiver and Release of Liability

READ CAREFULLY BEFORE SIGNING. THIS IS A RELEASE OF LIABILITY  
AND WAIVER OF CERTAIN LEGAL RIGHTS.

In consideration of my participation in one or more of the CMSC Alpine Race Series competitions, I

hereby acknowledge, that I understand that ski and/or snowboard racing/competition/training (hereinafter "Alpine Racing") is a hazardous activity and a dangerous sport which can lead to property damage, serious injury, or even death and that injuries are a common and ordinary occurrence. I understand and voluntarily agree to personally and fully assume any and all of the liability and risks of Alpine Racing. I understand that these risks include, but are not limited to; contact with racing gates and fencing, equipment failures or damage, speed of competition skiing, exceeding one's own abilities, the design, location, construction, inspection, maintenance, and repair of the race course and race hill, changes in terrain, inclement weather and changes in weather, reduced visibility, snow surfaces of all types, heavy snowfall, loose snow, ice, moguls, ruts, bare spots, rocks, bumps, stumps, debris, permanent and temporary fences, signs and banners, posts, trees, ski/snowboard equipment failures of any kind, presence and operation of snow making and snow making equipment, lift equipment and towers, rope tows and surface lifts, light poles, buildings, roads and walkways, padded and non-padded barriers and obstacles, slick surfaces, grooming equipment and operations, snowmobiles, and collisions with other competitors, other skiers, snowboarders, spectators and other persons, and other natural and man-made hazards.

Further, I agree to visually inspect all race and practice courses prior to all races and events. I agree it is solely my responsibility to determine the safety of race and practice courses for my ability level. I agree to have my Alpine Racing equipment regularly maintained, inspected and tested and replaced when it becomes worn. I acknowledge that the risks in the sport of skiing, snowboarding and Alpine Racing can be reduced by my taking lessons, by my abiding by the Skier Responsibility Code, and by my using common sense. During all Alpine Racing activities, I agree to wear a properly fitted and appropriate helmet for Alpine Racing and that it is my sole responsibility, and not that of any party released hereunder, to select my helmet and ensure my wearing of my helmet. I further agree not to participate in any Alpine Racing activities while I am impaired by the effects of intoxicants or medicines of any kind which may affect my ability to participate safely.

Further, I agree on behalf of myself, my heirs, survivors, guardians, legal representatives or assignees to hold harmless and release the Chicago Metropolitan Ski Council, the CMSC Alpine Racing Committee, and all of their board members, officers, sponsors, organizers, agents, representatives, volunteers, course setters, course workers, coaches and employees (hereinafter "CMSC"), and those of the ski hill at which each race is held, and any and all fellow CMSC race participants (hereinafter collectively referred to as "Releasees"), of and from any and all responsibility and/or liability for any and all property damage, personal injuries, death and any other losses or damages of any kind, which I may suffer or cause during and as a result of my participation in the CMSC Racing Series and any related events or social functions, even if such liability is caused in whole or in part by the negligence or other fault of CMSC or any other person or entity released in this Waiver and Release of Liability. I agree not to bring any action or lawsuit against CMSC, Releasees, and/or any other person or entity released in this Agreement and Release of Liability for any injuries, damage, death or any other losses. I agree to release, forever discharge, indemnify, defend, and hold harmless the CMSC, Releasees and/or any other person or entity released in this Agreement and Release of Liability, of and from any and all claims, suits, costs and attorneys' fees for damage, personal injury and/or death to me or my property resulting from any negligent acts or omissions by them.

Further, in consideration of my participation in the CMSC Racing Series, I hereby grant and release, without further compensation, to CMSC the right and permission to use, reproduce and publish my photographs, name and likeness, whether in still photographs, motion pictures, audio/video recordings, or other reproductions of me including my voice and features, with or without my name, for any promotional purposes involving CMSC and its sponsors, or for any other CMSC purpose whatsoever, except for the endorsement of any commercial products or enterprise unrelated to CMSC.

I represent that I have read and fully understand this Agreement and Release of Liability and agree to its terms of my own free will. I agree and represent that all portions of this Agreement and Release of Liability are supported by proper and the lawful consideration of my participation in the CMSC Racing Series. I understand that this Agreement and Release of Liability will apply to any and all events and functions which I attend or participate in the 2022-2023 CMSC Alpine Race Series Season (and/or the current race season).
